6. For papers based on IR&D and other in-house work, the company security officer may certify the form in Part III.
7. The cognizant Releasing Officer or Study Sponsor fills in Part III.
8. Part I should only be completed if the presentation is your own work, was not done under a government contract or IR&D and is approved for public release; distribution unlimited.
9.
